Representative Successes

• Insurance Coverage

Obtained a dismissal of claims against an insurance company, successfully arguing that the plaintiff's claims did not fall within the coverage provided by an attorney's errors and omissions policy. *J.K. v.* Scott Hawkins and Hawkins & Villemantte, LLC, 15th Judicial District Court for the Parish of Lafayette, No. 2008-1158.

Insurance Agent Liability

Obtained a summary dismissal of a claim that the insurance agent did not obtain the requested builder's risk insurance coverage. Ms. DeLaune successfully established, via dispositive motion that the plaintiff could not prevail on the malpractice claims if the issues were presented at trial. *Lifetime Building Materials, Inc. v. Assurance Company of America, et al.*, Civil District Court for the Parish of Orleans, No. 2006-9403.

Insurance Agent Liability

Obtained a decision upholding the dismissal of an insurance agent malpractice claim as untimely. Sharon B. Mumford, et al. v. Jackson National Life Insurance Company, et al., 2006-CA-1412 (La. 4th Cir. 2007), 968 So.2d 357.

Commercial Litigation

Obtained a summary dismissal of a third-party demand wherein a bank sought reimbursement from an account holder for payments made by the bank on fraudulent checks issued on the account. *Capital One, N.A. v. PNC Bank, N.A., United States District Court for the Eastern District of Louisiana*, No. 06-4135, Section D(5), 2008 WL 619157.

Commercial Litigation

Represented minority shareholders in a shareholder derivative action, resulting in a favorable trial verdict. This verdict was upheld on appeal. *Peter R. Harey, et al. v. Roland J. Joyce*, 280 F3d. Appx. 340 (U.S. 5th Cir. 2008).

Attorney Liability/Discipline

Ms. DeLaune and Mr. Wright obtained a summary dismissal, upheld on appeal, of a legal malpractice claim wherein the court found the attorney was not negligent in the handling of the underlying file. *Jeune Turner v. Associates Commercial Corp.*, et al., 03-CA-0224 (La. App. 5th Cir. 2003), 860 So.2d 244.

Obtained dismissals via dispositive motions of legal malpractice claims based upon peremption, failure to assert causation and failure to establish a breach on the standard of care.

Successfully obtained dismissals of bar matters involving trust account violations and other alleged violations of the Louisiana Rules of Professional Conduct.

Accountant Liability/Discipline

Obtained a favorable ruling from the Louisiana Accountant Review Panel in a matter involving an alleged failure to properly perform audit work.

Obtained a favorable ruling limiting the scope of fraud claims in accounting malpractice matters.

Obtained voluntary dismissals of accountant malpractice claims that were untimely and/or without merit.

Obtained dismissals of complaints pending before the Louisiana State Board of CPA's.

Insurer Liquidation - Reciprocity - Appeal

Handled this case where the Supreme Court held that Pennsylvania was a "reciprocal state" under Louisiana's Uniform Insurer Liquidation Act and that a Pennsylvania liquidation order deprived Louisiana courts of subject matter jurisdiction over all claims at law or equity against an insolvent Pennsylvania insurance company. *All Star Advertising Agency v. Reliance Ins. Co.*, 04-C-1544 (La. 4/12/05), 898 So. 2d 369.
